- 5.1.1 **Chairman:** Cllr W Mack and his wife attended the Civic Service organised by the Chairman of Wyre Forest District Council; Mark Garnier MP was in attendance.
- 6. CHADDESLEY CORBETT PARISH MATTERS FOR DISCUSSION/DECISION
- 6.1 **Neighbourhood Plan (NP)** Cllr D Thomas reported that the Referendum had taken place with 81% of those voting in favour, as a result of which Wyre Forest District Council had issued a Decision Statement and the NP had been 'Made'. It was agreed that the Steering Group would meet for the last time to set up a procedure for dealing with Actions identified in the NP.
- 6.2 **Old School Site Right to Bid -** A detailed report was submitted by the Working Group and was discussed in detail. In accordance with the recommendation made by the Working Group a partner was selected for preparation of the Bid. It was also agreed to appoint a solicitor to assist with preparation of the Bid and contracts with a budget of £2,000.
- 6.3 **Harvington Hall Lane:** Results of recent traffic surveys had been received and a meeting would be arranged with Worcestershire County Council to discuss further. It was felt that most of the traffic could be avoided if improvements could be made to Mustow Green island, and it was agreed that Stone Parish Council would be asked to join with us in making joint representations to the County Council.
- **Dog Fouling Campaign:** It was agreed to proceed with an awareness campaign to be carried out by Wyre Forest District Council Environmental Enforcement Officers.
