3. **PUBLIC QUESTION TIME:** None
4. **MINUTES OF THE MEETINGS** held on 4 January 2016, having been approved by the Parish Council, were signed by the Chairman.
5. **CORRESPONDENCE/INFORMATION RECEIVED:**
  - 5.1 15/0453/FULL – Drayton Grove – Following receipt of a letter from Cllr B Green, a joint response from our three District Councillors had been sent and copied to the Chairman. Cllr B Green indicated that as a protest at Wyre Forest District Council's decision to approve this application he would resign as a Councillor with immediate effect.
  - 5.2 Wyre Forest District Council – Draft Revised Planning Supplementary Planning Document was open for consultation. Cllr D Thomas would respond after liaison with other Councillors.
  - 5.3 15/0479/FULL – Astwood Cottage, Bournes Green – Revised plans received reducing the size of the agricultural shed by 25%. With this amendment to the proposal Councillors withdrew their objection to the development.
  - 5.4 15/0661/FULL – Throckmorton House, Mustow Green – Following receipt of a report from Highways which recommended approval of the application, Councillors decided not to change their previous decision to object to this planning application.
