Sexton's Fees per interment - Non-habitant or non-parishioner	£134.00
Search Fees for each search covering a period of not more than 1 year, each subsequent year to be at the Sexton's discretion	£25.00
Each certified copy of an entry of burial in the register books	£30.00
GRAVESTONES, TABLETS AND INSCRIPTIONS (only applicable where an Exclusive Right of Burial has already been purchased)	
Headstone in line with current Parish Council Burial Rules First Inscription	£175.00
Each inscription after the first	£35.00

These fees, payments and sums were approved at a Meeting of the Parish Council held on 5 September 2016 and ratified by them. These fees will come into operation as from 1 September 2016

EXUMATIONS

In the event of an Exhumation being ordered by a Magistrate or a Coroner and undertaken with the sanction of the Police, a fee equivalent to a similar Interment shall be charged.

In the event of a Re-Interment, the suitable Interment fee shall also be charged.

RULES

The fees indicated for the various headings:-

- (a) do not include the digging of the grave (Rule 12)
- (b) apply provided that the interment is made within 15 minutes of the time arranged with the Sexton. If not so made an additional £2.00 is payable in respect of each 15 minutes after that time(Rule 4)
